
SFO allows new employees to choose their preferred super fund.

*NOTE: If an employee doesn't provide their employer of their choice of fund, then the employer must provide the employee the Superannuation standard choice form within 28 days of their start date. To assist with the obligations of the employer, the SFO tool will send a notification and provide the employer with a link to the Superannuation standard choice form. If the employee doesn't nominate a fund, you can request details of their stapled fund, if any, in SFO.
